

DrawingSearcher Software License Agreement

PLEASE READ THIS LICENSE CAREFULLY BEFORE USING THIS SOFTWARE. BY CLICKING THE "YES" BUTTON OR BY USING THIS SOFTWARE, YOU AGREE TO BECOME BOUND BY THE TERMS OF THIS LICENSE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE, CLICK THE "NO" BUTTON, DO NOT USE THIS SOFTWARE, AND PROMPTLY RETURN IT TO THE PLACE WHERE YOU OBTAINED IT FOR A FULL REFUND.

IF YOU HAVE NOT PURCHASED A LICENSE OF THIS SOFTWARE AND ARE RUNNING IT IN "DEMO MODE" THE TERMS OF THIS LICENSE ARE STILL IN FORCE WITH THE ADDITIONAL CONDITION THAT THE SOFTWARE IS TO BE USED FOR NON-PRODUCTION, EVALUATION PURPOSES ONLY AND MAY NOT BE INSTALLED OR USED FOR MORE THEN A 15 DAY EVALUATION PERIOD.

The enclosed Docupoint DrawingSearcher application program ("Docupoint DrawingSearcher") is licensed, not sold, to you by Docupoint LLC ("Docupoint") for use only under the terms of this License, and Docupoint reserves any rights not expressly granted to you. You own the media on which the Software is recorded or fixed, but Docupoint and its licensors retain ownership of the Software itself.

1. **License.** This License allows you to:

(a) Use one copy of DrawingSearcher on a single computer ("DrawingSearcher Server") which may be accessed by multiple client computers ("Client") through a web browser interface. Each DrawingSearcher license is a single user "Floating network license" allowing for one (1) client user connection to the DrawingSearcher Server. DrawingSearcher contains a license management application that authorizes and monitors the number of licenses which are concurrently connected to the DrawingSearcher Server at the same time. If the number of licensed users is exceeded, a warning message is issued indicating a license is not available. If the DrawingSearcher application is used on a network/intranet or the Internet in conjunction with a proxy server or other software/hardware device that "masks" the IP address to the DrawingSearcher Server, the user/administrator remains responsible for administrating DrawingSearcher in such a way that the number of concurrent users does not exceed the number of licenses owned. To "use" the Software means that the Software is either loaded in the temporary memory (i.e., RAM) of a computer and/or installed on the permanent memory of a computer (i.e., hard disk, etc.).

(b) Make one (1) copy of DrawingSearcher in machine readable form solely for backup purposes.

(c) Notwithstanding any other terms in this License, if the Software is licensed as an upgrade or update, then you may only use the Software to replace previously valid licensed versions of the same software. You agree that the upgrade or update does not constitute the granting of a second license to the Software (i.e., you may not use the upgrade or update in addition to the software it is replacing, nor may you transfer the software which is being replaced to a third party).

2. **Restrictions.**

(a) The Software contains trade secrets and, to protect them, you may not REVERSE ENGINEER, DECOMPILE, DISASSEMBLE OR OTHERWISE REDUCE THE SOFTWARE TO ANY HUMAN PERCEIVABLE FORM EXCEPT AS PERMITTED UNDER APPLICABLE LAW. YOU MAY NOT MODIFY, ADAPT, TRANSLATE, RENT, LEASE, LOAN OR CREATE DERIVATIVE WORKS BASED UPON THE SOFTWARE OR ANY PART THEREOF.

(b) You may not transfer or assign your rights under this License to another party without Docupoint's prior written consent.

(c) You may not use the software or any components therein for any purpose other than it's intended use of providing integrated drawing and or document search, publishing (rendition to other file formats) and web server services. DrawingSearcher may not be integrated to other software applications or accessed in such a way as to circumvent the software license.

3. **Termination.** This License is effective until terminated. This License will terminate immediately without notice from Docupoint or judicial resolution if you fail to comply with any provision of this License. Upon such termination you must destroy the Software, all accompanying written materials and all copies thereof, and Sections 5, 6, and 7 will survive any termination.

4. **Export Law Assurances.** You may not use or otherwise export or re-export the Software except as authorized by United States law and the laws of the jurisdiction in which the Software was obtained. In particular, but without limitation, the Software may not be exported or re-exported (i) into (or to a national or resident of) any U.S. embargoed country or (ii) to anyone on the U.S. Treasury Department's list of Specially Designated Nations or the U.S. Department of Commerce's Table of Denial Orders. By using the Software you represent and warrant that you are not located in, under control of, or a national or resident of any such country or on any such list.

Docupoint's entire liability and your sole and exclusive remedy for any breach of the foregoing limited warranty will be, at Docupoint's option, replacement of the media, refund of the purchase price or repair or replacement of the Software.

6. **Limitation of Remedies and Damages.** In no event will Docupoint or any of the licensors, directors, officers, employees or affiliates of any of the foregoing be liable to you for any consequential, incidental, indirect or special damages whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss of business information and the like), whether foreseeable or unforeseeable, arising out of the use of or inability to use the Software or accompanying written materials, regardless of the basis of the claim and even if Docupoint or a Docupoint representative has been advised of the possibility of such damage. Docupoint's liability to you for direct damages for any cause whatsoever, and regardless of the form of the action, will be limited to the greater of \$100 (USD) or the money paid for the Software that caused the damages.

This License constitutes the entire agreement between you and Docupoint concerning the subject matter, and any proposals for additional or different terms, including but not limited to the terms set forth in any purchase order, are hereby rejected. Any waiver or amendment of any provision of this License shall be effective only if in writing and signed by both you and Docupoint. If any provision of this License shall be held by a court of competent jurisdiction to be contrary to law that provision will be enforced to the maximum extent permissible and the remaining provisions of this License will remain in full force and effect.
